\$200 if paid by January 22

## Lighthouse Christian School Financial Policies

- All Tuition and fees are non-refundable.
- The Consolidated Fee is due in June for Term and Monthly payment plans (due in May for Pay in Full).
- PTL Fees are due in August for Term and Monthly payment plans (due in May for Pay in Full)
- Enrollment fees and Re-enrollment fees will be deducted from your FACTS account after acceptance to the school or when the re-enrollment process has been completed.
- LCS has partnered with FACTS Tuition Management (FACTS) for collection of tuition and fees. Each family is required to register with FACTS. Payments for fees and tuition will not be accepted in the school office. For new students, details on FACTS Management will be included in the online enrollment packet. **For existing students, any changes to your payment plan option for the coming school year must be completed by January 31. In order to make changes, please email your preferred payment plan option to [whunt@thepinkchurch.org](mailto:whunt@thepinkchurch.org) no later than January 31. If no changes are made, your FACTS account will reflect the same payment plan as the current school year. **Any changes made to payment plans after your FACTS agreement is finalized will incur a \$50 administrative fee.****
- Any payments not successfully processed by the due date will be considered past due and will be subject to a \$35 late fee and a \$30 returned payment fee.
- Any student with an account 15 days past due may be prohibited from attending school until all past due amounts are settled. Parents will receive an email notification from FACTS notifying them a payment was unsuccessfully processed.
- Students may be registered but will not be permitted to start school in August until all past due balances from the previous year have been settled and all current year fees have been paid.
- No transcripts or test results will be provided until all financial responsibilities have been met.
- Active, contributing members of First Presbyterian Church of Pompano Beach may be eligible to receive a discount of \$750 per student. To apply for the member discount, a Church Member Discount Application must be completed and submitted to the school office by January 31. Church member discount applications will be approved or denied by the church business office. The Application is available at [www.lcsmariners.com](http://www.lcsmariners.com).
- Each family is required to provide 20 service hours to the school. Any hours not completed will be charged to your FACTS account at a rate of \$20 per hour.
- Financial Assistance is available on a limited basis. An LCS financial aid application and a FACTS Grant and Aid application are required for financial assistance. Please inquire at the front office for additional information.
- Withdrawals must be conducted through the school office. Report cards, student records and transcripts cannot be released until all outstanding obligations have been settled.
- LCS offers a referral fee program. Requirements for the referral fee program can be found at [www.lcsmariners.com](http://www.lcsmariners.com) or in the front office.
- LCS offers an After School Care program. The annual aftercare tuition is \$2,000 payable in 8 monthly installments (September - April) through FACTS. Aftercare is also offered on a "drop-in" basis. The drop-in rate is \$20 per child on regular school days and \$25 per child on early release days. Parents are billed for the drop-in service through FACTS.
